1. RULES

The regatta will be governed by the 2005-2008 Racing Rules of Sailing, the prescriptions of the United States Sailing Association, the Notice of Race, the Sailing Instructions and for PHRF divisions - the PHRF regulations of the YRA of LIS, and for one design divisions - the rules of the participating one design class.

2. REGATTA DESCRIPTION

Up to two races are scheduled for the Port Jefferson Harbor Cup depending on conditions. One race is scheduled for the Challenge Cup. Racing area will be Long Island Sound waters outside Port Jefferson - Mt. Sinai Harbor, New York. One race may constitute the regatta.

3. ADVERTISING

The regatta is classified as a Category A event in accordance with Rule 79, Advertising and Appendix 1.

4. ELIGIBILITY

Open to all yachts having registered and paid all regatta fees to Port Jefferson Harbor Cup. All entries must be accompanied by a current, valid PHRF certificate from the YRA-LIS or other sanctioning body, an appropriate one design measurement certificate, or a provisional rating will be assigned by the SYC PHRF handicapper. The Regatta committee reserves the right to refuse any entry.

6. REGISTRATION

The entry form must be completed and received, including full payment of the registration fee, by the Race Committee no later than Tuesday June 6th, 2006. The Race Committee reserves the right to reject the registration of any yacht received after the aforementioned date.

7. FEES

The registration fee for the Harbor Cup is \$45.00. The registration fee for the Challenge Cup is \$45.00. The registration fee for both regattas is \$60.00

8. SAILING INSTRUCTIONS AND SCRATCH SHEETS

The Sailing Instructions and Scratch Sheets will be available at the Setauket Yacht Club and from Race Committee auxiliary boats in the vicinity of the starting line prior to the warning signal for the first division of the first race.

9. MOORINGS

Setauket Yacht Club has a limited number of complimentary moorings available from Friday, June 9th, to Sunday, June 11th. Please call the Vic Suben at (631) 246-5170 for reservations. The SYC Dock monitors channel 68.

10. PRIZES

At Saturday's party "A Taste of Port Jefferson", trophies will be awarded to the first three places in each division, combining all of Saturdays' races. Trophies for Sunday, as well as overall regatta trophies, the Port Jefferson Harbor Cup, and the Roger Shope Memorial Trophy will be awarded at the Post Regatta Reception and Awards Ceremony. The Port Jefferson Harbor Cup will be awarded to the yacht club with the lowest cumulative score of their three best finishing yachts. One design fleets are excluded. To be eligible for this award, entrants must declare their yacht club affiliation upon registration. The Fixman Memorial Trophy will be awarded to the PHRF boat with the lowest cumulative score between the Port Jefferson Harbor Cup and the American Cancer Society Regatta. Qualifying race for North Sails: Long Island Sound Charity Cup, participation earns one point. The Saint Charles Hospital Trophy will be awarded to the yacht with the best overall finishing time in the Harbor Cup Regatta.
